TERMS AND CONDITIONS

BASCO Telephone Registration System
With the British Limousin Cattle Society

These terms and conditions explain the members' rights and responsibilities in using the BASCO database and those of the British Limousin Cattle Society.

Authority

The given member accepts these terms and conditions the first time they use this service. It is also the member who authorises the Society to accept and act on their instructions. The member is also responsible for all information sent to the Society either by him/herself as the given member or by someone acting on their behalf.

Security

Each member's user name and password details are unique. In the interests of security and to avoid errors, you should keep these details for your use only. If you lose or forget your password or feel it is insecure then simply contact the Society. The Society will send you a new password.

Availability of the service

It is intended that the Society provide the service to you at the times notified to you, for telephone registrations, within normal office hours. There will obviously be times when the service may be suspended for maintenance and the introduction of new facilities and services. In such instances, we will try and limit the time spent in doing this. The Society will not be liable for any failure to provide the service, in part or in full, in any instance or cause that is beyond its reasonable control.

Information sent to us

The Society's aim is to update a member's records on the BASCO database by the next day for telephone registrations received in full. The new information, in most instances, will appear on the BASCO database immediately and can be checked online.

If, in any instance, you realise that you have made a mistake in any of the information you send to the Society, you must contact the Society as soon as possible by e-mail or telephone. You will be asked to outline the details of the information you sent and the correct information. Please note that the onus is on the member to check the accuracy of the information on the pedigree certificates at the time of receipt.

Members' conduct

The given member must use the service in accordance with the Society's published business rules and byelaws only.

What will happen next

On receipt of this completed form, the Society will write to you with a user name and password to allow you to access the telephone registration service securely.

The Society will also issue you with a BLCS cattle log book which needs to be completed in full prior to telephone. This will act as your own written record of registration applications.

You will then be able to register by telephone.
